### **CONDITIONS OF ENTRY AND GENERAL INFORMATION**

1. Entry is open to both MV & Non MV Accredited pedigree registered sheep only. All consignors must be a full Member of the society and ensure their subscriptions are paid up to date.
2. The sale will be held subject to the rules and regulations of the Badger Face Texel sheep society, the conditions of sale as recommended by the LAA and the auctioneers standard conditions of sale.
3. Classes available for all ages of pedigree rams and females:  
**Class 1: Aged Ewe; Class 2: Shearling Gimmer; Class 3: Ewe Lamb**  
**Class 4: Aged Ram; Class 5: Shearling Ram; Class 6: Ram Lamb**
4. All sheep must be double tagged. The vendor shall be responsible for the correctness of identity. Any tags which are tampered with, handwritten / bear marks, are faulty or illegible will be rejected from the sale.
5. **PRE-SALE INSPECTION:** All sheep forward for the sale will be subject to a society inspection. Any animal which does not reach the inspection standard will not be eligible for show or sale. **The inspection decision will be final, and any animal failed must be removed immediately from the sale and forfeit the entry fee. No appeal is permitted.**
6. Please **DECLARE** in the notes next to the animal entered, if Semen has been taken or the ewe has been Flushed and/if Embryos collected.
7. A society levy of 1% will be deducted from the vendors account and paid to the Badger Face Texel sheep society. All sheep will be sold in guineas (105 pence) and a commission of 5% will be charged by the auctioneers on all sales.
8. All sheep entered for the sale must be fully pedigree registered prior to the closing date of entries. All pedigree certificates must be forwarded with the entry form.
9. An upset price will be set of 300gns on each sheep presented for sale.
10. Scrapie Genotyping is voluntary. Genotype information to be displayed in the sale catalogue must be supported by valid genotype certificates forwarded along with the sale entry forms and pedigree certificates.
11. Transfer Fee: A transfer fee of £5 will be charged to the purchaser if they wish to transfer their purchase into their flock.
12. Acceptance of stock: Due to Defra regulations, the arrival of stock can only be accepted onto the market premises within the time period stated in the sale catalogue. Any alteration will be notified to all vendors; however, we request that all arrival times published in the catalogue must be strictly adhered to.
13. Entry Fee: A fee of £8.40 per head will be charged on all entries (£7 +VAT) which must accompany all entry forms. Failure to do so will result in the entry being excluded from the Sale.
