All ponies must be 'Bona-fide Sold' by auction or the prize money will be withheld.

The location does not allow for ponies to be shown under saddle. Please ensure that information about broken or newly-broken ponies is included in the catalogue description overleaf.

Section IX (medical treatment) must be present in the passport prior to the sale, a passport is not valid without this page and to transport or sell a pony without a section IX is illegal.

NB this page cannot be added to the passport at the sale.

All ponies must be microchipped and the number recorded in the passport, prior to the sale. Microchips will be scanned and checked on arrival at the Mart. If a chip cannot be found, the owner of the pony has the option of calling a vet at their own expense - if the vet cannot find the chip but is able to conclusively identify the pony from the markings in it's passport, the pony may be re-chipped and may enter the Sale Ring. Otherwise, the pony may not enter the Sale and will need to be parentage tested to confirm that the passport is correct. If a chip is found which differs from that in the passport, the pony will not be allowed in the Sale Ring and the issue will be investigated. Purchasers are advised to check that the microchip/description of the pony they take away matches the passport.

Passports, together with a signed transfer certificate should be handed to FPS Secretary as soon as possible after unloading your pony.

The following regulations, introduced by the Animal Health Act 1991, **must be observed when selling foals.**

**Restrictions on the sale of foals** ('foal' here means a horse under the age of four months)

- 7 (1) No person shall bring or cause to be brought to a market a foal unless it is at the foot of it's dam.
- (2) No person shall expose for sale separately a foal which has been brought to a market at the foot of it's dam.
- (3) No person shall separate a foal from it's dam while -
  - (a) they are awaiting removal from the market after being exposed for sale; or
  - (b) they are being kept in a market (without being exposed for sale there) pending completion of their inland transit in Great Britain.

Older foals must be correctly weaned before being put forward at the sale - such foals have to be four months old or over. **For the avoidance of doubt, this means that foals born on or after 30th June 2021 are not eligible.** Foals being sold at foot with their dams must be at least three weeks old.

An up to date flu vaccination is recommended for all ponies and foals over 6 months old.

Only the handler, owner and Mart staff are allowed in the sale ring whilst an animal is being sold.
