Conditions of Entry and General Information

- 1. All sheep must be registered with the Dutch Spotted Sheep Society.
- 2. All sheep entered must carry an MV Accredited Status.
- 3. Scrapie genotyping is voluntary; if available please complete the relevant column on the entry form.
- 4. All Pedigree Certificates must be forwarded with the entry form.
- 5. Entry Fees (inclusive of VAT): £8.40
- 6. **PRE-SALE INSPECTION:** All sheep forward for the sale will be subject to a Society inspection. Any animal which does not reach the Inspection standard will not be eligible for show or sale. **The inspection decision will be final and any animal failed must** be removed immediately from the sale and forfeit the entry fee. No appeal is permitted.
- All sheep must be double tagged. The vendor shall be responsible for the correctness of identity. Any tags which are tampered with, hand written/bear marks, are faulty or illegible will be rejected from the sale.
- 8. No double entries are permitted.
- 9. Each vendor will be allowed up to two entries per show class.
- 10. Joint entries are not allowed. All members to enter their own sheep and be balloted individually.
- 11. All exhibitors should be dressed in a white coat at all times in the show ring.
- 12. No late entries will be accepted. It is the vendor's responsibility to ensure the entry reaches the office and recorded delivery is recommended.
- 13. All substitutes should be notified to the auctioneers at least 24 hours prior to the start of the show.
- 14. All sheep entered at In-Lamb Society sales are to be scanned at time of Inspection.
- 15. A Society Levy of 2% will be deducted from the vendors account and paid to the Dutch Spotted Sheep Society. All sheep will be sold in guineas (105 pence) and a commission of 5% will be charged by the Auctioneers on all sales.
- 16. An upset price will be set of 200gns on each sheep presented for sale.
- 17. Transfer Fee: A transfer fee of £5 will be charged to the purchaser if they wish to transfer their purchase into their flock.
- 18. Acceptance of stock: Due to Defra regulations, the arrival of stock can only be accepted onto the market premises within the time period stated in the sale catalogue. Any alteration will be notified to all vendors; however, we request that all arrival times published in the catalogue must be strictly adhered to.
