COMMISSION 1)

Commission will be charged to the vendors on each lot as follows: 10% on all items up to £200, then 5% on the next £201-£2000 and then 3% thereafter. A minimum commission of £1 per lot will be charged. A Lotting Fee of £1 per Lot will be charged. All commission charges are subject to VAT.

2) VAT
